Hire and Rental Industry Association (HRIA) Final Report for NHVR Heavy Vehicle Safety Initiative

31 July 2021

Introduction and overview

The Hire and Rental Industry Association Ltd (HRIA) is a not-for-profit industry association representing Australia's hire companies. Our membership consists of the country's leading hire providers as well as small business. The majority of our members (80%) are small, often family-owned businesses and many of these are in regional locations.

The HRIA has an important role to play when it comes to transporting hire and rental equipment in a safe manner, so delivering the NHVR HVSI-funded Chain of Responsibility (CoR) courses made perfect sense.

The HRIA, through its partnership with Engistics, ran 30 courses to deliver training in CoR and Load Restraint to the hire industry and its stakeholders (sub-contracting transport companies).

The course content included –

- CoR legislation
- Loaded vehicle mass and dimension
- Driver Fatigue
- Evaluation of supply chain key party capabilities
- Load Restraint

Through its provision of training sessions, the HRIA focussed on a wide reach when it came to geographical area covered. Although some of the remote locations had lower number of participants, these attendees took their newly acquired knowledge back to their companies and sub-contracting transport companies, who were able to improve or implement new procedures addressing CoR legislation. In the metropolitan areas, we saw a higher demand and ran additional courses in several locations.

COVID-19 meant that delivery of courses had to be adjusted according to lockdowns and border restrictions. However, the HRIA was able to offer the course to every location identified in its proposal. If a change was required, the NHVR was advised, and the course was re-scheduled so that it could be delivered safely when restrictions were lifted. The fluid nature of lockdowns made for some challenging times, but the HRIA was able to deliver 3 additional courses on top of its approved schedule of 27 courses.

Session assessment and feedback

At the beginning at each session participants were asked to sign in and at the conclusion they were asked to complete a survey. This information captured the number of people who attended each session and whether the information presented during the session was informative. The survey was also able to identify whether people took away some key messages and how likely the themes that were covered would result in implementing change in their business. Review and next steps

Engagement from industry stakeholders was excellent and since the HRIA completed its course roll out, there have been several enquiries regarding the next available CoR training. The HRIA will look to partner with Engistics to put on more training and these costs will be met by course participants and the HRIA.

Feedback from hire companies and their transport providers was overwhelmingly positive, with many commenting that this tailored training delivery was exactly what they needed for their companies. Areas of concern regarding risks, control measures and CoR were all addressed in the course. As participants returned to their companies and provided positive feedback, demand for more course places grew.

Given that demand has been constant, and particularly high in the metropolitan areas, the HRIA has applied for further funding for online CoR course development and delivery. Moving to an online platform, if successful in its funding application, the HRIA will be able to reach a far greater number of people and the learnings will be available 24/7. Participants in remote communities will have the same ease of access as those in the nation's capital cities.

The HRIA looks forward to more work raising awareness of CoR, both in face-to-face course delivery as well as through online learning.
