This form can also be used to amend or cancel of an existing vehicle standards exemption permit issued by a participating jurisdiction.

An application for amendment or cancellation of a permit should be made as soon as the details of the amendment or reason for cancellation are known.

- If additional space is required to complete a section, please include this in a separate document referencing the relevant section and part number e.g. 4 Vehicle details.

- multiple permits – a separate application for each permit is required.
